

UPOV

In 2018, 7 GEVES experts participated in UPOV technical working groups. GEVES brings to these working groups its technical, statistical and IT development expertise. The documents drafted by these working groups are then submitted for validation by the UPOV Technical Committee, in which GEVES participates, then to the Council, of which the Ministry of Agriculture is a member, with the legal and technical support of INOV. These validated technical documents are recommendations for the Member Parties of the UPOV Convention. They are the basis for the technical documents transposed at EU level which are binding for accredited examination offices, such as GEVES. These international meetings are an opportunity to build relationships with other countries and experts, and to establish new cooperation and training programs.

ISTA

GEVES is a member of ISTA (International Seed Testing Association) and is actively involved in developing new methods and sharing knowledge. 15 GEVES experts contribute regularly to the Executive Committee and the work of ISTA's 17 Technical Committees.

CPVO

GEVES experts in various technical working groups took an active part in preparing protocols, consolidating the operating rules of CPVO-entrusted examination offices, and reflecting on future developments.
